The candidates who have served for a period less than 5 years, upon selection, their tenure will automatically end on completion of five years.

If it is found at any stage of the process or thereafter that the candidate does not fulfill the eligibility criteria, their candidature shall be cancelled without assigning any reason whatsoever. Further, the decision of the Council in any matter relating to this, will be final. Interim enquiries will not be entertained and canvassing in any form will be a disqualification.
