1. Project Associate -1 (01 No.) (CRTDH -GAP 0402) – Project tenable at CSIO Unit, Chennai.

Qualification: B.E/B.Tech. in ECE/EEE/E&I

Stipend : (i) 31,000/- + HRA to Scholars who are selected through (a) National Eligibility Tests – CSIR-UGC NET including lectureship (Assistant Professorship) or GATE or (b) A selection process through National level examinations conducted by Central Government Departments and their Agencies and Institutions.

(ii) 25,000/- + HRA for others who do not fall under (i) above.

Age: Should not exceed 35 years as on last date of applying online. Relaxable up to 5 years in case of SC/ST, handicapped, OBC and physically female candidates.

Tenure: Initially for a period of 6 months likely to be extended till the duration of the project.

2. Research Intern (01 No.)

Qualification: B.E/B.Tech. in ECE/EEE/E&I

Desirable : Candidate with good academic record will be preferred.

Stipend: Rs.24,000/- per month

Age: should not exceed 25 years as on last date of applying online. Relaxable up to 5 years in case of SC/ST, physically handicapped, OBC and female candidates.

Tenure : 2 years.


Interested candidates who fulfil the qualification, age, etc. are required to apply Online through CSIR-CMC Website <http://www.csircmc.res.in> & click on "careers" and upload testimonials in proof of **Qualification, Age and Community (for SC/ST/OBC)**, and a recent **passport size photograph** on or before **27.05.2022 (5 PM)**. If a candidate wishes to apply for both the positions, they have to apply separately for each position.

Freshers will be eligible for interview, only if they are able to produce either Provisional Certificate or a consolidated mark sheet with the results.

The candidates who have already served in CSIR-CMC & its participating units or any other Lab./Instt. of CSIR as a Project Assistant / Project Fellow / Project Associate JRF / SRF / Research Associate etc. for a period of 5 years or more are not eligible for the above engagements.

If it is found at any stage of the process or thereafter that the candidates do not fulfill the eligibility criteria, their candidature shall be cancelled without assigning any reason whatsoever. Further, the decision of the Council in any matter relating to this, will be final. Interim enquiries will not be entertained and canvassing in any form will be a disqualification.

Based on screening of application, list of eligible candidates will be notified. They will be intimated the time/venue of interview by mail/SMS.
