With reference to CMC advertisement No. MC/01/2021 dated 14.02.2021, the lists of candidates recommended & not recommended for proficiency test for the post of JSA(G)/F&A/S&P) was notified on 29.01.2022. However, before conducting of proficiency test in February 2022, a circular letter No. 5-1(211)/2014-PD dated 14.2.2022 was issued by CSIR Hqrs. stating to treat Diploma qualification acquired after Xth as equivalent to XII standard.

Considering the stage of the recruitment process, a clarification was sought from CSIR Hqrs. whether at the stage Diploma candidates can be considered for proficiency test.

Now, CSIR vide letter no. 5-1(211)/2014-PD dated 15.11.2022 has given clarification. Based on the clarification, Screening Committee re-considered the eligibility of the Diploma Candidates for the posts of JSA (Gen.)/(F&A)/(S&P) :-

1. There is no change in the list(s) of candidates already recommended for proficiency test for the post of JSA(Gen)/JSA(F&A)/JSA(S&P) as already notified on 29.01.2022. (available in CMC website)
2. Candidates additionally recommended for proficiency test on possession of Diploma qualifications for the posts of JSA(Gen)/JSA(F&A)/JSA(S&P) out of the earlier not recommended candidates, is as follows:-
