RELAXATION IN UPPER AGE LIMIT

The date for determining the age limit, qualifications, etc., shall be the last date for submission of Online Electronic Applications i.e. 31.5.2021.

- 1. The upper age limit is relaxable up to 05 years for the regular employees working in CSIR Labs/ Institutes/ Government Departments / Autonomous Bodies/Public Sector Undertakings.
- 2. Relaxation of upper age limit for Ex-servicemen is admissible as per rules.
- 3. Age relaxation of 10 years in upper age limit shall be allowed to PWD (Divyang). Relaxation of age limit would be permissible to such persons who have a minimum of 40% disability.
- 4. Relaxation in the upper age limit of 5 years applicable for persons who had ordinarily been domiciled in the Kashmir Division of the state of Jammu & Kashmir during the period 1.1.1980 to 31.12.1989 subject to production of relevant certificate (Domicile Certificate) from the concerned authority.

- 5. Special age relaxation: up to the age of 35 years in the case of widows, divorced women and women judicially separated from their husbands. The persons claiming age relaxation under this sub-para would be required to produce following documentary evidence:-
 - In case of Widow, Death Certificate of her husband together with the affidavit that she has not remarried since.
 - In case of divorced Women and Women judicially ii. separated from their husbands, a certified copy of the judgement/decree of the appropriate court to prove the fact of divorce or the judicial separation, as the case may be, with an Affidavit in respect of divorced Women that they have not remarried since.

GENERAL BENEFITS

FEE

- 1. The post carry usual allowances (DA, HRA, TA, etc.) as admissible to the Central Government employees (7th CPC) and as made applicable to Council servants of the same pay and status stationed at Chennai.
- 2. Council employees are also eligible for accommodation of their entitled type as per CSIR (Residence Allotment) Rules, depending on availability, in which case, HRA will not be admissible.
- 3. In addition Medical Reimbursement, Leave Travel Concession, House Building Advance, Computer Advance and CEA provisions are applicable, as per rules.
- 4. The service under CSIR is governed under New Pension Scheme of GoI, w.e.f. 01.01.2004.

GENERAL **CONDITIONS**

- 1. The applicant must be a citizen of India.
- 2. Candidates should ensure that he / she has prescribed age, educational qualifications / experience etc. required for the post for which he / she is applying, as on last date for submission of Online application i.e. 31.05.2021.
- 3. The qualifications prescribed should have been obtained through recognized Universities/Institutions.



- 4. If any document / certificate furnished is in a language other than English or Hindi, a transcript of the same duly attested by a Gazetted Officer or Notary is to be submitted.
- 5. In case of Boards/Institutes awarding CGPA/SGPA/OGPA grades etc., candidates are requested to convert the same into percentage based on the formula as per their Board/Institute and provide proof of the formula adopted for the same.
- 6. Application from employees of Government Departments, Autonomous Bodies, Public Sector Organisations and Govt. funded research agencies will be considered only if forwarded through proper channel along with Vigilance Clearance duly certified by the employer that the applicant, if selected, will be relieved within one month from the date of receipt of appointment order. The applications received will be screened by a duly constituted Screening Committee which may short list the candidates by fixing educational qualifications/experience higher than that of the minimum notified and those candidates who, in the opinion of the Institute, suit the institutional requirements, will be called for Trade Test / Written Test. The candidate should therefore, mention in the application all the qualifications and experiences in the relevant area over and above the minimum prescribed qualifications, supported with documents.
